



INFORMAL AUDITION REGULATIONS FOR CHORUS CHORUS COLLABORATORS SELECTION – 2026–2027 SEASON

Organizer: "ION DACIAN" NATIONAL OPERETTA AND MUSICAL THEATRE, headquartered in Bucharest, B-dul Mihail Kogălniceanu nr. 70-72, sector 5, Tax ID (CIF) 4340099.

1. Date: September 9, 2026, starting at 11:00 AM (following the end of the registration period, candidates will receive an email with information regarding their assigned arrival time for the audition).

2. Location: "Ion Dacian" National Operetta and Musical Theatre, Bucharest, B-dul Octavian Goga nr. 1, sector 3 - Chorus Room.

3. Purpose of the selection:

The purpose of this external informal audition is to recruit guest chorus artists for the Chorus department in order to conduct artistic activities during the 2026–2027 season.

4. Requirements for participation:

- Candidates must be students or graduates of a specialized music faculty.
- Each candidate must be accompanied by their own répétiteur (accompanist) for the practical audition rounds.

5. Audition process:

The audition will consist of the following parts:

- Performance with piano accompaniment of a musical piece belonging to one of the following genres: operetta, musical, opera.
- Performance of a choral excerpt (selected by the panel) from the following productions:

My Fair Lady – Frederick Loewe (Soprano + Alto – No. 6 and 22; Tenor + Bass – No. 3 and 21)

The Gypsy Princess (Silvia) – Emmerich Kálmán (No. 6 – Act I finale)

Die Fledermaus (The Bat) – Johann Strauss (No. 11 – Act II finale)

The Gypsy Baron – Johann Strauss (No. 7 – Act I finale and No. 10 – "Work Chorus")

- Vocalise / Vocal warm-up exercise.

Candidate entry is permitted based on an ID card.

Candidates are kindly asked to arrive at least 30 minutes before the audition begins.

6. Results announcement:

Selection results will be communicated at a later date via email.

7. Availability:

Selected candidates must be available for artistic activities during the 2026–2027 season.

8. Required registration documents:

Completed and signed GDPR agreement (can be downloaded from www.opereta.ro, section ____).

Artistic CV.

(The absence of any document listed above constitutes grounds for incomplete registration).
